Tournament Rules

1. All participants must have bowled a 600 series during regular league play in a USBC [ABC] sanctioned league.
2. Entries will close 1/2 hour prior to squad time unless the squad is full.
3. All entrants must sign the official score sheets. Any error must be reported within 24 hours after completion of bowling.
4. The prize list will be based on at least 1 prize in every 10 entries. Checks will be awarded within thirty [30] days after the tournament closes.
5. In case of a tie in any division, the prize money for the tied positions will be added together and divided equally.
6. The tournament will be handicap and two divisions. Handicap will be 90% of 220 and the divisions will be as follows:
 - a. Division 1 – 175 and over
 - b. Division 2 – 174 and under
7. Each entrant will bowl 4 games across 4 lanes.
8. Highest USBC certified league average for the end of the previous winter season will be used. If no previous winter average, current highest USBC certified summer league average will be used. If no previous certified league average is available, the entrant must bowl scratch in Division 1.
9. USBC Rule 319a Item 2 regarding the increase in average does not apply.
10. Bowlers reporting incorrect averages will be disqualified in accordance with USBC Rule 319a, Item 3 if the mistake results in more handicap.
11. USBC Rule 319c on re-rating does not apply.
12. USBC Rule 319d requiring an entrant to report previous tournament prize winnings as a condition of entry does not apply.
13. USBC Rule 319e is waived.
14. Entrants must be USBC certified members for the current year.
15. Cost of bowling in tournament is \$16: \$10 for bowling & expenses plus \$6 for the prize fund.
16. Entrant may bowl once. No re-entry.
17. Tournament is USBC certified: Number 06161
18. The Tournament Director will decide any questions not covered in the tournament rules. Any decisions by the tournament director will be final unless an appeal is made in accordance with USBC Rule 329.
