

## LEHIGH VALLEY 600 CLUB TOURNAMENT RULES

1. The LEHIGH VALLEY "600" BOWLING CLUB shall conduct an ANNUAL TOURNAMENT for its members, the result of which shall determine the Championship of the Club. All participants must be members of the Lehigh Valley "600" Bowling Club.
2. The Annual Tournament shall be held in an association according to the rotation Plan set up by the Club; the current rotation is: Allentown, Slate Belt, Easton, Bethlehem, Monroe County and Palmerton. If any association declines, the rotation shall continue with the next association.
3. Entries shall OPEN four weeks prior to the Tournament Date and Close ½ hour prior to squad time unless squad is full.
4. The Secretary-Treasurer will be the Tournament Manager. The President will appoint one member from the Tournament City to secure lanes and scorekeepers in the Association where the tournament is held
5. All Entrants must sign the official score sheets. Any error must be reported within 24 hours. Where telescores and/or automatic scorers are available, they will be official.
6. The Prize List will be based on at least one prize in every ten entries. Trophies (charms) will be donated by the LV "600" Bowling Club. Checks in payment of money prizes won will be mailed to the winners within thirty (30) days after the close of the Annual Tournament.
7. In case of a tie for first place in any class, duplicate awards will be presented. However, the first and second place prize money will be added together and divided equally.
8. The tournament will be HANDICAP and in two divisions. Handicap will be 90% of 210 and the divisions:  
Division I – 165 and over                      Division II – 165 and under
9. The officers and directors of the LV "600" Bowling Club shall decide any questions not covered in the tournament rules and their decisions shall be final unless an appeal is made in accordance with USBC Rule 329.
10. Each entrant will bowl for (4) games across four (4) lanes.
11. Highest USBC certified league average for the end of the previous winter season will be used. If no previous winter average, current highest USBC certified league average for 12 games or more as of the closing date of the tournament will be used. Previous highest summer USBC certified league average will be used. If no average for present season, entrant must bowl Division I. USBC Rule 319a(3) – Failure to use the correct average shall disqualify the score if submitted average is lower than required and results in more handicap, the bowler's score is disqualified. The 10 pin or more increase in average of USBC Rule 319a(2) does not apply. USBC Rule 319d requiring an entrant to report her previous tournament prize winnings as a condition for entry does NOT apply. USBC Rule 319c on re-rating does NOT apply.
12. Member must be USBC certified for the current year.
13. Tournament Entry Form will be sent to "all" members in good standing.
14. Unless otherwise notified by Tournament Manager, first choice time requested will be honored.
15. Cost of bowling in tournament: Bowling & Expense Fee: Option of the Tournament Manager based on current lane prices, Prize Fee: \$6.00.
16. Entrant may bowl ONCE. No re-entry.
17. Unmarried grade and high school students 18 and under must file parental consent form before bowling.
18. Lehigh Valley "600" Bowling Club dues may be mailed with entry.
19. All winners' averages are subject to verification by the Tournament Manager.
20. USBC Rule 319e is waived.
21. This tournament is USBC certified.
